Negotiations with public safety unions offer a unique challenge to public employers because of public safety union access to Act 312 binding interest arbitration. Act 312 arbitration is the final step of negotiations in the event the parties are not able to resolve the terms of their collective bargaining agreement. Understanding Act 312 and how it impacts the entire negotiations process is critical in a public employer's ability to achieve its collective bargaining goals. This session will cover the origin and development of the Act 312 statute, preparation and presentation of an Act 312 arbitration case, and strategies for negotiations with an employee group that has access to Act 312 arbitration.
