#### **Hotel Reservations**

Hotel reservations must be made directly with Grand Traverse Resort & Spa. Reserve your room by August 24, 2025: Hotel Guestroom \$179.00 or Tower Guestroom \$209.00. Room rates are per room, per night and are based on single/double occupancy, and subject to a 6% state tax, 5% assessment fee, and \$20.95 per room, per night resort fee. Additional adults in a guest room will be charged a \$15.00 per person, per night rate. Credit card required to make reservations, and must be presented upon check-in. To receive the conference discount rate, you must provide the group code 1MPELRA, and your hotel reservations must be made by August 24, 2025. Rooms at the group rate after August 24, 2025 are based on availability.

#### **Attire**

Business casual is appropriate for all MPELRA training sessions and social events. **Note:** The heating, ventilation and air conditioning systems are controlled by the on-site facility. Every effort will be made to maintain the room temperature at a level that will be comfortable for all participants.
